Eligibility Requirements/Terms & Conditions

1. Window air conditioners and ceiling fan(s) must be **purchased between 06/01/2016 and 09/30/2016**.
2. Only **Energy Star air conditioners** with an Energy Efficiency Ratio (EER) of **11.2 or higher quality** for the rebate. **All Energy Star ceiling fans qualify** for a rebate, no minimum Energy Efficiency Ratio (EER) required.
3. Rebate **applications must be submitted no later than one month after appliance is purchased**.
4. Rebate incentives are limited to one rebate for an air conditioner and up to two fans per household; account holder must purchase appliance.
5. Rebates will be paid for replacement of existing appliances only. New appliances for newly built homes are ineligible.
6. Rebates are limited to residential customers; commercial entities, commercial customers & residential new construction do not qualify.
7. KIUC reserves the right to discontinue or change the rebate levels without notice.
8. Participants must complete a rebate application and submit it along with a copy of a detailed purchase receipt.
